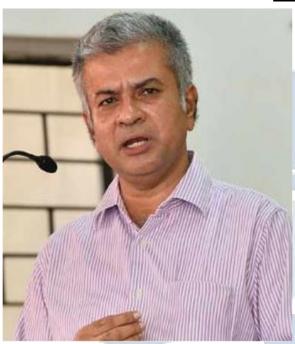

THE NEED FOR NEW LEGISLATION TO REVAMP AND RESTRUCTURE SOCIAL MEDIA IN INDIA

Abstract: -

Social media as the name suggests, is the media for the society where society's welfare to be protected as well as preserved. Social media where the active spot for interaction between people by sharing of information, ideas, pictures etc became the routine aspect for everyone. Social media is the hub of enjoyment. Apart from its various benefits of education, connectivity, awareness, free usage etc, it builds up the structure for deforestation of people's life. The illegal crimes committed in social media which includes the cyber bullying by way of threatening and harassing, cyber stalking, hacking and fraudulent activities, hate speech includes sedition and defamatory statements, online abuses especially to women and children, censorship matters pertaining to restrictions on part with content creators, creation of fake profiles, vacation robberies, indecently representing the women and outraging her modesty, pornography and obscenity material etc. The existing laws of constitution Article 19(1) (a) of freedom of speech and expression, where media flows through it, section 66(a) of IT Act, 2000 of protection for offences created in social media and rendering of punishment, other complementary laws alone cannot protect and safeguard the users of social media which is a multinational dominion. There is a need of the hour for separate legislation in the eyes of the social media apart from existing laws. As the society grows, protection grows, and still with the enforcement of laws. The article delves into the various wrongful activities committed in social media to users, along with contrary laws and suggestion regarding separate Act for social media as for revamping and restructuring as in this highly technology driven world there is a concern for special legislation as to social media. The act of doing fraudulent transactions is mostly happening in the cyber virtual areas with the help of the cheating type of people who formed as a group and involved in cheating activities. The hate speech includes the sedition and the defamatory statements. Sedition means whoever, by words, either spoken or written, or by signs, or by visible representation, or otherwise, brings or attempts to bring into hatred or contempt, or excites, or attempts to excite disaffection towards, the government established by law in India, shall be punished with imprisonment of life, to which fine may be added, or with imprisonment which may extend to three years, to which fine nay be added, or with fine⁷. So the sedition can also in the online platform towards the government and punishment as a remedy should be imposed. Defamation means, whoever, by words either spoken or intended to be read, or by signs or by visible representations, makes or publishes any imputation concerning any person intending to harm, or knowing or having reason to believe that such imputation will harm, the reputation of such person, is said, except in the cases hereinafter excepted, to defame that $person^8$. The defamation can be categorized or been separated into two types, of which first comes the libel where the defamatory statements can happen by way of the written one, which is in the type of the printed format, the second comes about the slander, where the defamatory statement happens by way of spoken words, gestures etc. The defamation is a punishable offence and whoever tries to defame anybody in the virtual platform will be punished. Both the form of the hate speeches of defamation and sedition in the social media networking apps are increasing and there is a need

for new separate amendment instituted under the preview of the social media legislation by the parliament of India.

- Online abuses including abuses to women and children: The online abuses and cheating activities especially happening by targeting the way towards the innocent children and women. The women's and children's are been affected more by the way of online abuses. There were been sexually exploited, tortured and been harassed in the online platforms. The activity of online abuses happens via in the social media apps. For ex:- when the women or a teenager has an account in the social media apos, they can get fake profiles, where these innocent people also accepts their request and these people in the back screen present in the fake profiles plays an intensive game targeting these people and for their benefit they will treat these innocent faces as mere the slaves for themselves.
- Censorship matters pertaining to content creators: A content creator looking to monetize is driven by two imperatives that work as strategic advantages for their commercial activities: authenticity and entrepreneurial spirit⁹. The content creators gained it's major widespread in the modern world of living. The content creators make their choice of the content and publishes or uploads the same in the social media platforms. These people need the proper certificate of commencing with the censorship matters pertaining to them. They should act with the proper content and to create the good awareness in the society should be their main aim and the goal. They should be possessing with the what type of video content they are uploading, the advantages and disadvantages of the particular topic of the video which is been uploaded in the social media apps should not be aggressive, harmful, sensitive etc and it should have the protection for both the people as well as to the content creators in the society.
- Creation of fake profiles: There has been the creation of fake profiles in the social media apps. The fake profiles which is been created which affects each and every people from using the social media apps. For ex: many people are creating the fake profiles in the Instagram app on with other name and pictures used, by this fake profiles these people are trying to cheat others by way of behaving and talking

- Vacation robberies:- The vacation robberies are the robberies who tries to the steal the products or any goods from the house or any other place where there is an absence in the case of the owner, when the owner is not present in the place where he is been staying. In that case the vacation robberies goes to the owners place and do the activity of stealing. These robberies are called by the name of vacation, where their stealing work is been based on the vacation purposes and not present at all the times. With that the there were also many offences arising from the this.

Existing laws for the social media: -

• The Constitution of India: - The right to freedom of speech and expression¹¹. There has been rights granted fir each and every citizen with the rights conferred under Constitution of freedom of speech and expression. In this part under this there are also reasonable restrictions which is been laid down with the rights that have been provided. The right to media flows through the concept of the right to freedom of speech and expression. The right to media includes about the social media, the fourth pillar of the media with the general heading that is been provided. With the

main law which is been provided under the indian Constitution lays down as the most fundamental and basic rights to media. The right to media cannot be revoked by anyone and by anytime with the subject to the restrictions provided under the same clause.

• Information technology Act, 2000:- Punishment for sending offensive messages through communication service etc, any person who sends , by means of computer resource or a communication device,

a) any information that is grossly offensive or has menacing character; or

b) any information which he knows to be false, but for the purpose of causing annoyance, inconvenience, danger, obstruction, insult, injury, criminal intimidation, enmity, hatred or ill will, persistently by making use of such computer resource or a communication device;

c) any electronic mail or electronic mail message for the purpose of causing annoyance or inconvenience or to deceive or to mislead the addressee or recipient about the origin of such messages, shall be punishable with imprisonment for a term which may extend to three years and with fine 12 .

Indecent representation of women (prohibition) Act, 1986:- Prohibition of advertisements containing indecent representation of women, No person shall publish, or cause to be published, or arrange or take part in the publication or exhibition of, any advertisement which contains indecent representation of women in any form ¹³. Prohibition of publication or sending by post of books, pamphlets, etc., containing indecent representation of women, No person shall produce or cause to be produced, sell, let to hire, distribute, circulate or send by post any book, pamphlet, paper, slide, film, writing, drawing, painting, photograph, representation or figure which contains indecent representation of women in any form:

Provided that nothing in this section shall apply to—

(a) any book, pamphlet, paper, slide, film, writing, drawing, painting, photograph, representation or figure—

(i) the publication of which is proved to be justified as being for the public good on the ground that such book, pamphlet, paper, slide, film, writing, drawing, painting, photograph, representation or figure is in the interest of science, literature, art, or

learning or other objects of general concern; or

(ii) which is kept or used bona fide for religious purposes;

(b) any representation sculptured, engraved, painted or otherwise represented on or in—

(i) any ancient monument within the meaning of the Ancient Monument and Archaeological Sites and Remains Act, 1958 (24 of 1958); or

(ii) any temple, or on any car used for the conveyance of idols, or kept or used for any religious purpose;

(c) any film in respect of which the provisions of Part II of the Cinematograph Act, 1952 (37 of 1952), will be applicable 14 .

The need of the hour for new legislation in the eyes of the social media:-

There arises the need of the time and the hour for the new legislation to be adopted for the separate social media considering about it's various offences committed and disadvantages it possess. The social media should be enacted and have a separate legislation where all the types of the offences can be tackled and punished, where the legislation in itself has punishment as well as the remedies for the violation and enforcement of the social media. The Act of social media should include about the various offences, the remedies, regarding the social media apps, and how each and every one especially the women and children need to be very careful and cautious while using the social media. The President needs to give assent for this Act by the way of the majority of it's seats in the election's in both the houses of the Parliament. This needs to be come in force for the protection and the welfare of the society, also for the development and the growth of the social media apps and the technology which is been associated with it.

Report by NCRB on the cyber crimes: -

The crime committed in the social media is been on the rise and it is increasing as due to the technological advancement and with new path way of the artificial intelligence. The offenders found new way of committing crimes around the circle of cyber crime which revokes everyone from women to the children ruining their overall life cycle. The crime rate where on the rise from 3.9 in 2021 to 4.8 in the year 2022, cases of cyber crime reported on the surge of 24.4% totalling 65,893 cases from 52, 974 cases in the year 2021, cyber frauds committed in the social

media accounted for 64.8% of the registered cases , which followed by extortion of 5.5% and the sexual exploitation of $5.2\%^{15}$.

Conclusion:-

But considering about the various offences, there is an need of the hour for the enactment of the social media legislation. The laws created under the social media should play a major role in transforming and creating new potential for the people, by transforming the society into the more viable and security standards for the people.
