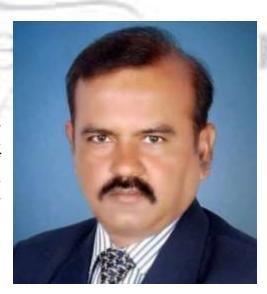

## **ABSTRACT**
