

- 2- Handling the conflict and promotion of cooperation⁷- The United Nations tries to prevent diplomacy which can result in conflict or tension among the nations of the globe. The mediator's role is being played by the United Nations Security Council and the United Nations Secretary-General. UN clearly emphasizes the role of negotiations, and mediation to avoid conflict and to maintain peace and order in society
- 3- No use of arms and weapons- The United Nations clearly states to avoid the use of any kind of nuclear weapons which can result in conflict and disagreement among the member countries. It is done to ensure peace and harmony in society along with the safety and safeguarding of the environment and the surroundings.
- 4- The protection and safeguard of basic rights and human rights- The United Nations
 Committee ensures the maintenance of human rights through various treaties like the
 Universal Declaration of Human Rights and mechanisms like the Human Rights

Council which focuses on ensuring basic rights, human rights, justice, and equality among all the member countries of the United Nations organization.⁸

In 1948, UN Peacekeeping Forces were formed mainly to prevent armed clashes and to open a neutral channel for deliberations between the parties in contention. This remedy can only be availed when both parties accept their intervention in their respective condition. It became a yardstick for the effective promotion of basic human rights which sets out an important precedent for future generations to look up to. They're further categorized into two groups, namely, Unarmed Observer Groups & Lightly armed military forces. The role of Observer Groups is to accumulate real ground reality data and perceive the state of affairs in an area. At the same time, the military forces are delegated with more hard tasks like maintaining peace and security in an area and minimal use of offensive powers in case of self-defense.⁹

The truce between Israel & Arab States in 1948 was the first time Observer Groups formally visited and imparted their expertise to negotiate peace in the area. Many more crucial missions by UN peacekeeping forces helped to create cordial relations among nations in different regions like the Middle East, Asia, Africa, etc. For instance, in Namibia (1989), with sagacious convincing of UNTAG (United Nations Transition Assistance Group) assisted them in conducting the first free elections in the nation ending decades of civil war & mutiny resulting in the stable Namibia we see nowadays. Also, in the case of Cambodia (1990), the establishment of UNAMIC (United Nations Advance Mission in Cambodia) by the Security Council strengthened them to put ceasefire and created a democratic setup. In Burundi (2004), UN Operation in Burundi (ORUB) was initiated to create & support the locals to restore peace and national reconciliation as promised under the Arusha Agreement. It was succeeded by the UN Integrated Office in Burundi (BINUB).¹⁰

UN working to have a future of peace and sustainability.

The United Nations has successfully conducted various operations where the war has been stopped, and peace has been maintained. The United Nations treaties and agreements including
