New international criminal law seeks to gain the authority to U.N. principles into practice and to classify war terrorism and violations of human rights as official international crimes. International crime, which is any injury or major act that harms or touches a person and their rights and reverses the peace of the country and affects all economic and social political relations of other countries and political presers of some.
